Signed on this 30 day of June 2003 at Kleinmond.




ADENDA

- *He was a worker and member of his father' s crew in the fishing business.
- *Helped with the diving of abalone.

2.) Grandfather : P.J Fredericks SEN

- *He was the first disadvantage person who had his own boats.
- *In the early sixties he had two trawlers,

- *In the 1980' s he had a variety of boats ;
Seaweed boat - Pauly
Abalone boat - Julinda & Dolphina, Denise
- *Seaweed had been harvest by him, today seaweedquota.
- *As grandfather he took us on trips on the sea.
- *We helped him with his fish catch eg. Snoek season (Processing & Marketing)
- *His daughter later worked in a processing factory in Kleinmond harbour.
- *My grandmother and uncle' s processed his fish.

Abalone:

- *Tuna Marine , Hermanus , received his abalone.
- *I was involved in the packing of abalone.
- *He and his son , Trevor , was holders of abalone quotas.
- *After the death of his diver , Daniel Arendse , he resigned, because his other divers started diving for themselves.
- *I was taught to swim by him, D. ARENDESE
- * Divinglessons did not occur , because Daniel drowned of severe heartattack while diving in 1984 on duty.

3.) Great Grandfather : Samuels M.J-019622 410 K **ID -personsdocument attached**

- *He was a fisherman and lived in the old fish harbour.
- *One of his boats can still be seen today in the Hermanus old harbour museum.
- *Was the grandfather of Nolan, Micheal, Franky, Gilderoy Swartz and Ivan (АВКАНАМ) Oncker.
- *His decendants full filled his occupation.
